We've made updates to the Atrezzo UI design system to improve visual consistency, accessibility, and scalability across products. These updates include the introduction of an optional large-type accessibility theme that increases font sizes by 2px. Current font sizing remains accessibility compliant, and users can also adjust text size using standard browser zoom settings.
